1. **Date:** Saturday, August 24, 2024
2. **Event Time:** 3:00pm to 9:00pm
3. **Location:** Raven parking lot on the corner of 6th Street and Phillips Avenue in Sioux Falls, SD
4. **Event:** This is a fun market that combines several local makers, food, drink, and entertainment all together at one location.
5. **Licensing:** You are responsible for getting a special event food license from the department of health for the day of the event.
6. **Fees:** Booth fee is \$125 plus tax for a total of \$133.13 Payment will be due by check 14 days after notification of selection. Credit card payment accepted with \$2 service charge.
7. **Application process:** Submit your completed application and 4-7 photos that best represent your food to 605made@gmail.com. The application deadline is midnight, Friday, April 5, 2024. **No late applications will be accepted.**
8. **Selection notification:** There will be a limited number of makers chosen to participate in the 605 Made Night Market. A jury process will determine the participants based on your completed application, submitted photos, and type of product. Notification by email of the selected makers will be made by Friday, April 19, 2024.

If you are selected:

9. Set up will begin at 12:00pm on Saturday, August 24, 2024
Tear down will be at 9:00pm (no early tear down)
10. You are responsible for your own truck/tent set up and tear down.
11. If you are in a tent booth, ONE 120v/15A electrical outlet will be run to your area (this is to be used for LIGHTING ONLY, not to run equipment). You are responsible for an extension cord and lighting within your own booth. Electricity will NOT be available to food trucks. Trucks must have a quiet running generator as to not disturb the music & attendees.
12. You are responsible for your own event liability insurance and compliance with any and all requirements of the State of South Dakota.
13. There will be **no refunds** once accepted to the event, even if the event is hindered or canceled due to weather, or for any other situation. All funds are fully committed to the production, promotion and marketing of the event.
